PROGRESS ON THE INTERNATIONAL BUS TERMINAL PROJECT

Synercon Consulting, in collaboration with KPEC (Khyber Pass Economic Corridor), is progressing with the Master Plan and Feasibility Study for the International Bus Terminal to enhance travel between Afghanistan and Pakistan.

A recent joint meeting at the KPEC office brought together key officials from NHA, UPPU, Transport, and KPUMA. During the session, Team Lead Mr. Nadeem Shaikh presented a SWOT analysis to select the best site for the terminal. Our team proposed three potential sites, each covering over 20 acres. Additionally, a new site near Takht-a-Baig, District Khyber, was suggested by the Project Director (KPEC), and a follow-up site visit was conducted with the Assistant Commissioner (AC) of Jamrud.
